#### **6 Lessons Coronavirus can Teach Us About Climate**

**Change** (earthday.org) Earth Day 2020 comes at a tumultuous time. COVID-19 has upended our lives and if there was ever a time in which humanity should finally recognize that we belong to one connected family on Earth, this should be it. We share a single planet, drink from the same water and breathe the same air.

- **1. Science matters.** We can save lives by funding and accessing the best science available. The science on climate change has been clear for decades, but we've failed in communicating the danger to the public, leading to slow action and widespread denial of the facts.
- **2.** How we treat the natural world affects our well-being. The loss of habitat and biodiversity creates conditions for lethal new viruses and diseases like COVID-19 to spill into human communities. If we continue to destroy our lands, we also deplete our resources and damage our agricultural systems.
- **3.** The sooner we mobilize for action, the less suffering will take place. Quick and drastic action can flatten the curve for coronavirus. Similarly, drastic action on climate change could reduce food and water shortages, natural disasters and sea level rise, protecting countless individuals and communities.
- 4. We have the ability to make drastic changes very quickly. All over the world, healthy people are changing their lifestyles to protect more vulnerable people. Similar dedication for climate change could transform our energy consumption immediately.
- **5. All of us are vulnerable to crisis, though unequally.** A society burdened with social and economic inequality is more likely to fall apart in a crisis. Industries and people who profit from an unjust status quo will try to interrupt the social transformation that a crisis requires.
- **6.** Holding on to a vision of a just, peaceful and sustainable Earth will give us strength for the future. Business as usual--digging up fossil fuels, cutting down forests and sacrificing the planet's health for profit, convenience and consumption--is driving catastrophic climate change. On our 50th anniversary of Earth Day, as fear and illness sweep the globe, find solace in the natural world. In the suddenly quiet streets and skies, we can hear birds sing.

# Will Growing International Concerns About Biomass Energy Trickle Down to the L'Anse Warden Electric Company?\*

A University of Calgary School of Public Policy Briefing Paper, Volume 12:29, September 2019 states: "The IPCC (Intergovernmental Panel on Climate Change) should take the biomass/biofuel pathway off the table and countries that have been the major devotees to this illusionary method for climate change mitigation should phase it out."

Policy recommendations include an increase in afforestation (planting trees where they haven't been planted before) and reforestation and soil carbon enhancement while restricting land clearance to reduce heat-trapping emissions that cause global warming.

\*Sixty-eight Finnish climate, environmental and ecological scientists wrote a public letter in March 2017 raising concerns over the climate and biodiversity impacts of Finland's forest policy. They highlight how a "Bioeconomy" which promotes the idea that wood-based fuel and wood-based products are always carbon neutral and therefore climate friendly, is essentially a myth.

#### **UP Energy Task Force Update**

Folk organized a public "Listening & Update" event at the Portage Lake Pubic Library on February 22nd. Two members of the UP Energy Task Force, Jenn Hill and Roman Sidortsov, gave an overview of the UP energy system with updates on the first phase of the Task Force work on the UP propane supply structure. This was informal, not an official Task Force meeting.

The UP Energy Task Force was created by Governor Whitmer's Executive Order in June 2019 to assess the UP's overall energy needs and how they are currently being met. In cases of energy disruptions, the Task Force was to formulate alternative solutions for meeting our UP energy needs, with a focus on security, reliability, affordability, and environmental soundness. The final draft went to the Governor on March 31st, 2020. Public comments to be submitted by April 6th, 2020.
